#### Word from the Chair:

- Communicated the updated approach for the Committee.
  Including a copy of the GB Business Calendar (available on the LBPSB website 02-04 Word from Chair...). The EESC will proceed with an approach of discussing upcoming Governing Board activities in order to communicate and manage expectations for parent involvement and requirements in the GB process.
- Selection Criteria for the Appointment of Principal
  - o This is reviewed annually at your school
  - o Think of it as a "job description", or the equivalent of a job posting.
  - It is renewed annually in preparation for a vacancy. Renewal does NOT mean there will be a change in Principal at your school, this is only preparation in case a change is determined by the Board or is required because the Principal moves on.
  - The selection criteria is a "wish list" or characteristics important in a Principal for your school.

#### Sex Ed

- Material was distributed and reviewed.
- Communication about the approach, curriculum or school specific implementation was extremely limited / non-existant.
- Pilot locations have been determined, priority should be to get feedback from these locations and share with other parents.
   Riverview and Christmas Park are pilot locations?
- Follow up was recommended and requested of the Parents Committee as this was an item with a lot of uncertainty.

## Annual Report

- o Sample was reviewed and discussed.
- Given the school board 5 year plan has expired and with the MSC changes coming into effect, many of the measures are out of date.
- Key item that will remain relevant is the Tell Them From Me (TTFM) section of the report. This deals with the STUDENT perceptions and feelings within your school. These stats are particularly relevant related to previous years, LBPSB averages and Canadian averages.
