PARENTS' COMMITTEE MEETING THURSDAY, FEBRUARY 20TH, 2025 6:30PM ON ZOOM

1. Call to Order with Land Acknowledgement

D. Bentley called the meeting to order at 6:31pm. All participants were asked to name themselves, their school, and whether they were a Rep or Alt. Quorum was established with 28 out of 46 LBPSB schools and SNAC being represented. He then invited C. Michaud to recite the acknowledgement of Mohawk land.

2. Word from the Chair

D. Bentley welcomed all attendees and thanked them for joining the meeting. He acknowledged the presence of the Chair of LBPSB, J. Kelley as well as all Regional Directors. D. Bentley noted that he would try to move swiftly through the agenda.

3. Approval of the Agenda

D. Bentley proposed the following changes to the agenda: Item 11. would now be changed to Regional Subcommittee Breakout Rooms and Item 12. would now become Adjournment of the meeting. He called for any further changes. There were none. He then called for a motion to approve the agenda. It was moved by T. Curtis that the agenda be approved. The motion was seconded by C. Michaud. None were opposed, and no abstentions were noted. The motion was unanimously resolved.

4. Approval of the Minutes (January 2025)

D. Bentley invited Reps/Alts to propose any changes they may have to the minutes. There were none. He then called for approval of the minutes of January 2025. It was moved by Z. Meltzer that the minutes be approved. The motion was seconded by K. Mandel. None were opposed, no abstentions were noted. The motion was carried.

5. Correspondence

D. Bentley noted that no correspondence had been received.

6. Business Arising

6.1. Website Subcommittee

D. Bentley invited M. Kashetsky as Chair of the Communications Committee to provide an update. M. Kashetsky noted that everything was status quo and that an update would be provided in time for the next meeting.

6.2. Internal Rules Subcommittee

D. Bentley reported that the subcommittee is in the process of going through the Internal Rules. The proposed changes will be posted on BAND, with recommendations to be brought to the PC shortly.

7. Ouestions from the Public

D. Bentley invited members of the public to pose their questions. The following items were highlighted:

Q. A parent from St. Thomas asked to be directed through the proper channels regarding the lack of local field trips planned at their child's school. It seems that there are grad trips planned which are not necessarily feasible for everyone. This has been brought up with administration.

A. D. Bentley responded that most of the PC would probably agree that the PC was a great place to mention it and that it could also be mentioned at the GB where a request could be made to bring it to Staff Council.

In fact, it had been brought up at GB and it was mentioned that the GB only approves field trips. The GB recommended that the topic be brought up at the PC. K. Mandel indicated that he will bring it up with the Principal and the GB.

A comment was made that there is an upcoming event on April 29^{th} where all High Schools on the Island of Montreal have been invited to participate in a Social Activism event taking place at Centre Mount Royal.

8. New Business

8.1. EPCA Survey

D. Bentley reported on the EPCA Survey. The following items were highlighted:

- EPCA sponsored a National survey on Family Well-being (2nd edition)
- LBPSB Admin sent it out to parents
- As of the time of this meeting, 10,000 responses had been received
- Comments were made regarding the fact that the language used did not completely follow the question, most likely due to the text being translated

8.2. School Calendar 2025-2026

D. Bentley noted that there were changes made to the calendar as three PED days were moved. He explained that every year, the PC looks at the options that the Calendar Committee has presented for upcoming school years.

D. Bentley highlighted the differences between Options 1, 2, and 3 of the 2026 -2027 School Calendar.

- Differences include start days, Christmas holidays, and the last day of school
- The difference between Option 1 and 3 does not affect parents
- Option 2 scatters the Christmas holidays over 3 separate weeks
- Option 3 was recommended by the Calendar Committee and the PTU
- A comment was made questioning whether parents have a say in the Calendar options. It was noted that it is important to get parental feedback.
- D. Bentley called for approval of Calendar Option 3. None were opposed, and no abstentions were noted. Calendar Option 3. was approved.

9. Reports

9.1. Administration

D. Bentley invited V. Marin's to speak to the Administration report. The report was included in the kit. The following items were highlighted:

- Due to the snow days, the PTU vote regarding calendar options was delayed
- Violence Prevention Week will take place from March 17-21, the government has asked school boards to organize activities related to this theme (more information to follow)
- End of term two- report cards to be sent out. Please consult the schools web site for more information.

D. Bentley invited parents to ask questions. There were none.

9.2. School Board Committees

- General discussions took place with regards to the concept of promoting Micro Forests at different schools and their positive environmental impact

D. Bentley invited Reps/Alts to present items under Varia. The topic of School Lunch Fees was mentioned. It was noted that a fee of \$2.50 was paid for each child by their parents. It was pointed out that in one school, there seemed to be a discrepancy in Daycare budgets. An inquiry was made as to where these funds are going. Another parent mentioned that at their school, there is a huge deficit as many parents refused to pay this fee. It was noted that these fees are often spent on activities. In some cases, the fees for morning/lunch and afterschool care seemed to be lumped together. It was suggested that maybe they should be itemized. Administration agreed to take this information back to the proper channels. At this point in the meeting, attendees were told that there would be a 5 minute break until the start of the Regional Subcommittee Breakout Rooms.

11. Regional Subcommittee Breakout Rooms

Reps/Alts were divided up by region and invited to participate in their designated Regional Subcommittee Breakout sessions where each Chair of the Subcommittee, along with each Regional Director helped to facilitate discussions.
